

5) The Governing Body shall consider the audited accounts and forward their opinion on the administration and financial matters of the society and the institutions to the General Body for consideration.

15) BUSINESS OF THE GENERAL BODY

1) The General Body shall be convened once in a year ordinarily in the month of August to consider the Audited statments and all the matters forwarded by Governing Body. The body shall be convened within one month on receipt of requisition with Agenda from 1/6 th of the total eleigible members of the General Body.

2) The General Body shall elect the office bearers and the Members of the Governing Body to hold tehir office for a term of two years.

3) The quorum for a meeting shall be 1/3 of the total eligible members. Half of the total members for General Body Meeting and 1/4 for Executive body meeting.

4) All the resoultions are passed with a simple majority vote and in case of tie, the President have a casting vote in addition to his own.

5) The General Body Meeting shall be held on the same date of the next month at the same place and time, when the quorum is in-sufficient to conduct the business and noted on the notices sent to memebrs and no further notice is necessary for such meeting of the next month and such meeting shall consider the agenda irrespective of the quorum and all resolutions passewd in the said meeting are deemed to have been passed by all the members of the General Body.

6) The Minutes of every meeting shall be recorded in a book specially kept for the purpose and the same shall be signed by the Presdient and Secretary at the end of the meeting.

7) The Governing Body may remove the primary membership of any member from its rolls with 3/5 majority of members present, when the activities of such person/persons are found detrimental to the interests of the society of the institution.

8) The General Body may consider any subject that may be brought into the meeting by the Secretary with the permission of the President.

9) Any Member failing to attend the three consecutive meetings shall cease to be a member automatically.

16) GENERAL

1) The financial year of the Society shall be 1st June, to 31st may and may be altered by the Governing Body to suit their convenience by recording a resolution in the Governing Body minutes book.

2) The General body shall have the power to add/alter/replace/change/delete any of the above article/articles with 3/5 majority of the total eligible members in a meeting specially convened for the purpose after one month .

3) To hold/ manage/ purchase / sell/ lease/ mortgage or other deal with property relating to the Society as it shall be good and proper.

4) To receive funds either in kind or coin from any other charitable organisations or persons for the develop-ment of the organisation.

5) The Society may take over any other Society or Association with similar objectives and nature on request and such request may be considered and accepted by the Governing body of the Society.

6) The funds shall be spent only for the attainment of the objectives of the Society and no portion thereof shall be paid or transferred directly or indirectly to any of its members through any means.
